





Introduction and overview

Global Health Development|The Eastern Mediterranean Public Health Network (GHD|EMPHNET) is pleased to invite qualified vendors to submit proposals for the Bidding of PCR (Polymerase Chain Reaction) machines. This initiative funded by Centers for Disease Control and Prevention CDC US, aims to provide three PCR machines to the Ministry of Health in Iraq, as part of a global health development initiative to modernize the PCR machines at CPHLs (Central Public Health Laboratories) in the above-mentioned country. We are seeking bids from reputable vendors who can supply high-quality PCR machines that meet the specific requirements outlined in this document.

Country: Iraq

Number of PCR Machines Required: 2

Requirements and Specifications: Listed below.

Bid Proposal Submission Receipt Deadline: 30 days – May 6 – June 5, 2024. 23:59.

Tender opening day: June 6, 2024.

Evaluation and Vendor Selection: 5 working days – June 13, 2024.

Implementation and Follow-Up: Commencing 2 months after contract signing (to be fully completed by August 22nd, 2024)

Terms and conditions

- 1. Supply includes installation at the specified site by GHD|EMPHNET.
- 2. Offers should be received in English language only.
- 3. The contractor is required to visit the site and inspect it within one week of receiving the purchase order to prepare the site according to the necessary requirements.
- 4. The contractor is obligated to conduct necessary and sufficient training sessions for operating and using the machine at the specified site.
- 5. The contractor commits to providing free maintenance for the machine, including all consumable and damaged/defected spare parts and everything necessary for the machine's operation, for a period of 3 years from the date of receiving the devices.
- 6. The contractor is required to provide an original copy of the operation manuals upon machine delivery and an original (or electronic) copy of the maintenance manuals.
- 7. The contractor commits that the delivery period of the machines will not exceed one month from the date of receiving the purchase order.
- 8. The contractor commits to affixing labels indicating the name and address of the local agent (phone, fax).
- 9. The contractor commits to providing new (100%) machines and the latest models from the manufacturing company, stating the manufacturing date, and ensuring that production has not been discontinued upon receiving the purchase order.
- 10. During the free maintenance period, the contractor commits to responding to service requests by phone, supported by fax and email, within (24) hours.
- 11. The contractor commits to repairing the machine and returning it to service within (48) hours from the date of reporting the malfunction, and otherwise, the contractor commits to replacing the faulty machine with a new, working machine of the same specifications and quality level or better.
- 12. For referral purposes, it is required that a local agent for the manufacturing company be available with an engineering team qualified and trained by the manufacturing company to maintain the machines, along with providing names of the team and their technical experiences and original (or certified) training certificates in the field of the supplied machines. This condition is considered essential for referral purposes.
- 13. The tenderer commits to specifying the manufacturer, country of origin, and place of manufacture, as well as providing a copy of the certificate of origin upon request and affixing a non-removable thermal label indicating the country of manufacture (Made in...).
- 14. In case of updates on the machines regarding hardware and software, the contractor commits to providing them free of charge for the operational lifetime (or the duration of the agreement or contract); which longer of the two terms; of the machines requiring such updates, and the contractor commits to providing all related data periodically and promptly upon approval by the manufacturing company.
- 15. The contractor commits to providing an original or certified copy of relevant CE MARK or FDA APPROVAL certificates upon receipt.
- 16. Submission of the company's registration documents.
- 17. The contractor commits to providing a performance bond worth 10% of the referral value in the form of a certified bank check.
- 18. GHD reserves the right to cancel, withdraw, or reject any bid or offer without providing any reasons. Including its right to withdraw/cancel the bid itself.
- 19. GHD is not obliged to select the lowest price, nor is it obliged to select any of the bidders without providing any reasons.
- 20. All transactions related to the bid and subsequent relationship with the successful bidder (including during negotiation stages) shall be subject to the prevailing laws of the Hashemite Kingdom of Jordan, and the Jordanian courts (Amman First Instance Court/Palace of Justice) shall have jurisdiction to settle any disputes arising thereof.
