



Request for Proposal for Sample Collection Supplies

Introduction and Overview

Global Health Development (GHD) is pleased to invite qualified vendors to submit proposals for the Bidding of Sample Collection Supplies. This initiative aims to provide sample collection supplies to Sudan Federal Ministry of Health. These supplies are vital components in the broader effort to enhance the capacity of Central Public Health Laboratories (CPHLs) within Sudan, as part of a concerted global health development initiative.

We are seeking bids from reputable vendors who possess the capability to supply high-quality Sample Collection supplies that meet the specific requirements outlined in the accompanying document.

Country: Sudan

Bid Proposal Receipt Deadline: 10 days – April 21 -30, 2024. 23:59 Amman time.

Tender opening day: May 1, 2024.




Evaluation and Vendor Selection: 5 working days - May 5, 2024.



Contract Negotiation and Finalization: May 9 ,2024.




Implementation and Follow-Up: Commencing 2-week after contract signing.

Keep in mind that using official channels for submitting a sealed bid may require some additional time and the associated cost will be fully covered by the applicants.

Terms and Conditions

1. This is door-to-door delivery to Sudan Federal Ministry of Health at this location: Federal Ministry of Health, Alsoug Road/ Port Sudan - Red Sea State – Sudan
2. The selected vendor responsible for handling customs clearance for this procurement.
3. The contractor commits that the delivery period of the Sample Collection supplies will not exceed one month from the date of receiving the purchase order.
4. The contractor commits to affixing labels indicating the name and address of the contractor (email, phone, fax).
5. The packaging must be of good quality, capable of withstanding transportation and storage conditions, and clearly labeled with the batch number and expiry date for sterilized materials.
6. The vendor must provide sufficient samples with the submitted bid for all materials to be presented to the technical committee studying the tender.
7. The contractor pledges to provide new, high-quality Sample Collection supplies, ensuring they meet the latest standards and specifications required for effective sample collection and transportation.
8. The contractor is required to specify the manufacturer, country of origin, date, and place of manufacture for the Sample Collection supplies.
9. A copy of the certificate of origin should be provided upon request, and a non-removable label indicating the country of manufacture (Made in...) should be affixed on the supplies container.

10. The contractor commits to providing an original or certified copy of relevant quality or ISO certificates.
11. Payments schedule will be decided later with the selected vendor.
12. Performance guarantee: It is 20% of the contract value. (or equal to the first payment)
13. Submission of the company's registration documents is required as part of the tendering process.
14. All submitted bids will be evaluated based on the predetermined criteria set by GHD. Each vendor will be notified of the decision following the evaluation process.
