

# Partners' Engagement Framework-Targeted Country Assistance (PEF- TCA) for Sudan, GHD|EMPHNET support

## **OBJECTIVES**

This project aims to "strengthening immunization program system including routine immunization services, surveillance, and outbreak investigation and response in Sudan". The overall aim will be achieved through supporting cohorts of PHEP-SPO in the context of emergency and conflict, ensuring the functionality of a coordination committee during emergency, improving vaccine demand generation and community engagement, and strengthening immunization data quality.

#### REGIONS OF WORK

This project will be implemented in Federated Government of Sudan.

#### PROJECT DESCRIPTION

#### BENEFICIARIES

The main beneficiaries of this project are Surveillance/EPI officers, technical working groups and committees, governance/technical bodies in Sudan.

#### **PROJECT Activities**

This project involves six main activities:

<u>Activity I</u> – Support three cohorts of the Public Health Empowerment Program (PHEP-SPO) training <u>Activity II</u>- Conduct an evaluation of PHEP-SPO training.

<u>Activity III</u> – Support the implementation of the coordination mechanism.

<u>Activity IV</u> – Develop guidelines for NITAG functionality during emergencies and conduct an Evidence to Recommendation (ETR) Workshop

Activity V- Develop a creative communication strategy.

Activity VI- Support the enhancement of community-based surveillance and its implementation.

"Partners' Engagement Framework- Targeted Country Assistance (PEF- TCA) for Sudan, GHD|EMPHNET support" is a 2.5-year project. The project follows a comprehensive approach outlining six key outcomes to realize its overarching goal. Initially, it focuses on strengthening the technical capacities of Surveillance /Expanded Program on Immunization (EPI) officers to enhance immunization, surveillance, and outbreaks investigation and response. Achieving this involves conducting three cohorts of Public Health Empowerment Program-Surveillance Polio Officer (PHEP-SPO) in the context of emergency and conflict. The second outcome entails enhancing the PHEP-SPO program and its impact in the context of emergency and conflict through conducting an evaluation for the first PHEP-SPO cohort. The third outcome aims to ensure the functionality of a coordination committee during emergencies and beyond through supporting the implementation of the coordination committee. The fourth outcome concentrates on strengthening capacity of governance/technical bodies for planning, coordination, and tracking progress at all levels to guide the immunization policy.

This will be achieved through conducting Evidence to Recommendation (EtR) training workshop for National Immunization Technical Advisory Group (NITAG) members.

The fifth outcome centers on improving vaccine demand generation and community engagement to increase the use of services by beneficiaries. This will be achieved through developing a creative communication strategy. And finally strengthening immunization data quality through strengthening community-based surveillance.

## **Currently...**

The immunization program in Sudan is facing a number of challenges. Recurrent outbreaks such as cVDPV2 outbreak in 2020 and 2022, Measles outbreaks in 2019, 2020, and 2021, and diphtheria, pertussis, and neonatal tetanus cases took place in many states. These repeated outbreaks indicate significant gaps in the delivery of essential vaccines to rural areas. Surveillance systems remain weak due to inadequate resources and capacity-building initiatives been have not effectively implemented. Outbreak investigation and response is hampered by limited resources, leading to delayed detection and management of disease outbreaks. Besides the current political situation. Therefore, multi-stakeholder action is essential to enhance the accessibility to quality healthcare services and protecting people of Sudan from infectious diseases.

### What's next...

This project aims to enhance the capacity of EPI officers to prepare for, respond to, and recover from public health emergencies, such as disease outbreaks or natural disasters. It also aims to improve coordination in immunization programs during emergencies, ensuring transparent, equitable, and timely decisionmaking. Additionally, the project will enhance communication to address sustainability issues, improve service fairness, and develop strategies for hard-to-reach groups. It will also boost data collection and complement facilitybased surveillance systems by gathering data rural. and hard-to-reach from remote. communities.
