SCOPE OF WORK

The main objective of this project is update

The project's main beneficiaries are EPI district officers.

REGIONS OF WORK

This project will be implemented in Sudan targeting the 18 states.

PROJECT DESCRIPTION

In 2021, GHD supported the Sudan Federal Ministry of Health (FMOH) in training the locality immunization officers on microplanning and 18 state micro-plans were developed. The need to revise the microplans annually was recommended by all states and further conveyed by EPI-FMOH. Based on the previously achieved outcomes and the country-specific needs, GHD will support conducting subnational microplanning meetings at the 188 districts that aim to complement the national microplanning meeting. This activity will start by recruiting a technical coordinator in Q1 to follow-up on the implementation of district and health facility plans. In each of the 18 states, a 4-days review meeting will be conducted in Q2-Q3 targeting their respective EPI district officers to conduct a situational analysis and develop a district-specific EPI microplanning. A total of 188 EPI district officers will be targeted.

Phase I: Conduct 18 4-day review meetings targeting 188 EPI district officers.

What is next . . .
