

# Establish community-based surveillance for AFP in border provinces in Lebanon

## **OBJECTIVES**

GHD will establish community-based surveillance for Acute Flaccid Paralysis (AFP) in bordering provinces in Lebanon following the declaration of the polio case in OPT in March 2022 as it is indeed considered an alarming threat, amidst declining immunization coverage and surveillance indicators.

# **REGIONS OF WORK**

The project will be implemented in Lebanon.

### **BENEFICIARIES**

The targeted beneficiaries are community informants from target provinces and PHEP trainees.

# **PROJECT PHASES**

This project involves four phases as follows:

**<u>1.Planning Phase:</u>** Conduct coordination meetings, develop guidelines and SOPs, advocacy material and pictorial health messages.

**2.Training Phase:** Train Epidemiological Surveillance Unit at Ministry of Health (ESUMOH) officers on providing ongoing mentoring and guidance to the community informants.

**<u>3. Reporting Phase:</u>** Report AFP cases by community informants from target provinces.

<u>**4.** Adapt PHEP training</u> curriculum to Lebanon context and conduct the PHEP training for estimated

In the last two years, the COVID-19 pandemic, socioeconomic instabilities, and the unprecedented high turnover and immigration of medical personnel have all taken a heavy toll on Lebanon's health system. Considering the trend of declining immunization coverage and surveillance indicators, the polio case reported in OPT in March 2022 is indeed seen as an alarming threat. Given this context, GHD will implement a community-based surveillance system for AFP in neighboring provinces. In addition, it will provide resources to help facilitate coordination meetings. Standards of practice, advocacy tools, and visual health messages will be created. Community informants will undergo training, receive nine months of prepaid phone credits, and ongoing mentoring and guidance. Number of community informants trained and number of AFP cases reported by community informants in target provinces will be used to evaluate the success of this activity. The outcome is the improved rate of non-polio AFP (NPAFP) in those provinces.

Also, GHD will support Lebanon MoH in implementing one cohort for 25 participants in Public Health Empower Program (PHEP).

# Currently . . .

The COVID-19 pandemic, socioeconomic instabilities, and the unprecedented high turnover and immigration of medical personnel have been particularly detrimental to Lebanon's health care system over the past two years. In light of deteriorating immunization coverage and surveillance indicators, the polio case that was discovered in OPT in March 2022 is, without a doubt, regarded as a cause for grave concern. In this light, the GHD has proposed the establishment of communitybased surveillance for AFP in neighboring provinces.

### What's next . . .

Acute Flaccid Paralysis (AFP) surveillance is known as the gold standard of polio surveillance as active case finding (ACF) is the primary symptom of poliomyelitis infection which is mainly seen in children below 15 years of age. Thus, the goal of AFP surveillance is to detect, report and evaluate all AFP cases so that poliomyelitis can be ruled out as the cause of the paralysis.

Implementing a community-based ACF in Lebanon will enhance the reporting of all AFP cases and the detection of polio cases amid the declined immunization coverage and surveillance indicators.
